### The procedure for applying foreign citizens on the issue of extending the period of stay in the Russian Federation<sup>1</sup>

**The territorial divisions of the Ministry of Internal Affairs of Russia at the level of St. Petersburg districts and the Leningrad Oblast districts (link to the list of addresses) receive the following categories of citizens:**

- **Foreign citizens** who arrived in the Russian Federation based on visas for the purpose of entering “private”, “tourism” - the validity of existing visas is extended to 90 days, in case of expiration, the temporary stay of foreign citizens is extended to 90 days on a motivated request (with any specific form) on the extension of the temporary stay period, without extending the visa.
- **Foreign citizens** who have arrived in the Russian Federation in a manner that does not require a visa, including Russian Federation international agreements on short-term visa-free travel for certain categories of citizens and in the case of expiration of a permitted period of temporary stay for this category of people, temporary stay period increased to 90 days based on a motivated request (with any specific form) to extend the period of temporary stay.

**The Department of Migration Registration, Visas and Invitation of the Ministry of Internal Affairs of Russia for St. Petersburg and Leningrad Oblast is located at **St. Petersburg, 15 Krasnogo Tekstilshchika Street, the entrance is to the left on the main entrance, first floor, window №135.****

**For foreign citizens who arrived in the Russian Federation on the basis of business, commercial and work visas, the validity of existing visas is extended to 90 days.** In case of expiration, the temporary stay is extended to 90 days based on the motivated statement (in the arbitrary form) to extend the period of temporary stay with subsequent transit visa issuance for departure from the territory of the Russian Federation.

**The transit visa issuance for the departure from the Russian Federation is carried out:**

- **until April 1, 2020** by the Labor Migration Department of the Migration Affairs Directorate of the Main Directorate of the Ministry of Internal Affairs
- **after April 1, 2020** by the Migration Registration, Visas and Invitations Department of the Migration Affairs Directorate of the Main Directorate of the Ministry of Internal Affairs (St. Petersburg, 15 Krasnogo Tekstilshchika St.).
